The foreign drivers can pay the entry fees at the administrative checking.

The receipts for payment of the entry fee will be handed over at the administrative checks.

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

- **4.5** Entry fees may be refunded only:
  - to candidates who are not accepted,
  - in the case of the Competition not taking place,
  - if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50 % only of the entry fee will be refunded.
- **4.6** For the RB160 division, a uniform fuel of Natural 100 is specified. Fuel Station: Orlen, Červené Vršky 992, 256 01 Benešov u Prahy.

### 4.7 Practice

Each qualifying practice session will be run over 4 laps and first lap is not counting.

#### 7. **INSURANCE**

#### 7.1 Insurance coverage of the organiser

The Autoklub CR concluded with "Allianz Insurance, a.s.", through the company PLATINUM Consulting s.r.o., the frame insurance contract No. 550012623 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 50.000.000.

#### 7.2 Insurance of competitors and drivers

The part of the frame insurance contract No. 550012623 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 50.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

7.3 Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

#### 8. **NOISE CHECKING**

For all cars a limit of 100 dB is imposed. For RB cars a limit of 110dB.

#### 9. PRIZES AND CUPS

The prizes will be awarded in Euros. Prize fund net of taxes distributed as per Article 15.2.2 of the Sporting Regulations

#### 10. **OTHER INFORMATION**

#### 10.1 **Competitors' Liaison officer**

The Competitors' Liaison Officers will be recognisable by waistcoat with the inscription "COMPETITORS' LIAISON OFFICER". He may be reached: In the Race control.







# 10.2 Protests - Appeals

Protests must be submitted in accordance with Art. 13 of the Code.

All protests must be in writing and must be forwarded to the Chairman of the Stewards. In the absence of the Chairman of the Stewards, such protests shall be delivered to one of the other stewards, or in their absence, to the race director or the clerk of the Course. The protest must be accompanied by the amount of 14.000 CZK. If the protest requires the dismantling and reassembly of various elements of the car, a deposit of up to 250,000 CZK is required from the protesters.

The competitors have the right to appeal, in accordance with Art. 15 of the Code. The amount of the deposit in case of appeal is 26.000 CZK.

### Appendix 1

a) The driver, mechanics and escort will wear a visible sign throughout the race, which will receive 1 + 4 pieces at the administrative check or on arrival at the premises.

Due to the limited capacity of the depot, no additional escort vehicles will be admitted to the complex. An exception may be granted by the organizer, but the competitor is obliged to place this vehicle in his own reserved space, which was allocated to him in the depot by the organizer. To identify the vehicle will receive the competitor must have a marking visibly affixed to the vehicle. Violation of the agreed provision Parking of vehicles outside the driver's place in the depot can be fined by a contractual penalty in the amount of CZK 10,000. **b)** During the whole weekend, a ban on the use of motorcycles, ATVs and other motor or electricvehicles is issued in the entire motoring area of the racecourse and other adjacent private lands under a fine of CZK 10,000 for riders and their companions. An exception may be granted by the organizer

c) Night rest is set at 24.00 - 06.00 hours.

**d)** Upon arrival at the car park for racing machines, the riders will be allocated a parking space according to the instructions of the car park manager.

e) During the entire race weekend, the use of private drones is prohibited under a fine of CZK 20.000.
